

# TERMS & CONDITIONS OF ENROLMENT

## 1. The Agreement and Definitions

1.1 We agree to sell, and you agree to buy the Learning Platform on the terms and conditions set out below.

1.2 'Course' means the Key Stage and Year for which your child is enrolled, including all related learning materials and support.

1.3 The 'Period' of the Course is the time over which the curriculum is provided. The maximum Period for the Course is one year, if you wish to continue to the following year, or move up a Key Stage, the fee will continue.

## 2. Fees and Payment

2.1 The fees are payable over instalments or can be paid in full.

2.2 If paying over instalments, a month in arrears must be paid.

2.3 Monthly instalments can be cancelled anytime, but you will lose one month of fees. Re-registration will result in an admin fee will be levied.

2.4 If paying in full, you can cancel within 45 days for a deducted refund. There is no cancellation after 45 days.

## 3. Services Provided

During the period of your Course, we will provide support for the use of the Learning Platform.

## 4. Parents' Agreement

Parents agree to support their children taking a course with One 1 One Homeschooling, including:

- Going over with the use of the Learning Platform with their child;
- Amending or agreeing the daily timetable to which their child can work;

- Spending an appropriate amount of time discussing progress with their child. 'Appropriate' will naturally vary with the child's progress and learning ability;
- For children enrolled for Early Years or Primary courses, that they will be with their child full time during their studies, except where the child is engaged in an activity that does not require parental support, such as watching a video, or answering an assignment or quiz.

## **5. Examinations and Results**

5.1 If your child is sitting an external examination at the end of their Course, you will be responsible for making arrangements with a convenient exam centre for your child to sit for the examination, and for payment of the examination fees. We strongly advise you to make sure your child will have access to an exam centre before enrolling on a key stage 4 course.

5.2 If your child is taking an examination course, you agree to advise us of the examination result.

## **6. Change of Course**

6.1 If your child wishes to transfer to a different Course at any stage, we will provide every assistance.

6.2 In this event we will transfer the fees paid towards the new course.

## **7. Deferring a Course**

You cannot defer a Course, if you or your child wish to defer a Course to a later date than that for which you originally enrolled.

## **8. Warranties and Limitation of Liability**

8.1 We warrant that our learning materials will be of good quality.

8.2 We warrant that we will provide your child with all services with reasonable skill and care.

8.3 We shall not be liable for injury to anyone or for any damage caused during practical science experiments performed at home or elsewhere. No harmful or toxic substances are required for any of the practical work, and parents are responsible for ensuring the safety of the environment in which their child is working.

8.4 We shall not be liable for: (a) losses that were unforeseeable by both parties when this Agreement was made; (b) losses that were not caused by any breach on our part.

8.5 Our liability for direct losses arising out of our negligence, breach of contract or any other cause of action in connection with this Agreement shall be limited to the total amount that you have paid for the Course.
